Dear Ms. Mandrell,

This letter is in response to the conceptual site plan submitted to the City of Westerville and the curb cut location. The Right of Way is within the City of Westerville but the site is located outside the City of Westerville.

The City of Westerville accepts the location of the curb cut as shown on the submitted conceptual site plan, attached.

The following items are required before the Site Improvement Plans are signed/approved by the City of Westerville.

- Final Site Improvement Plans shall be submitted to the City of Westerville
 Engineering Division for review and approval. The plans shall be submitted to
 the City's plan review portal.
- Provide an estimate of trips using the latest Institute of Transportation
 Engineers' (ITE) trip generation methodology and definitions. This information
 includes Daily Trips and AM & PM Peak hour trips generated by the
 development.
- The drive approach shall be shared with the parcel(s) to the west if the parcel(s) to the west redevelop. A private access agreement shall be recorded before the City of Westerville approves the Site Improvement Plans.
- Use Delaware County Standard Drawing for the Commercial Drive Approach (DCED-R2203A, the maximum slope shall be 4% and plan for a 10' sidewalk/bike path area with 1.56% cross slope.

- If outletting storm water to the City's public storm sewer within the City's right
 of way, provide a stormwater management report for review and approval. The
 report shall be submitted to the City's plan review portal and follow Delaware
 County Engineer's requirements.
- Provide Right of Way (by Warranty Deed) that matches the alignment and width of Harris Automotive and the properties to the west. The Right of Way shall be provided to the City at no cost to the City. With the additional Right of Way being granted to the City, City will also require this area to be annexed into the City, an annexation plat will be required.
- The Site Improvement plans and requirements shall meet the satisfaction of the City Engineer.
